

Privacy Policy

This privacy policy sets out how Dr. Fischer uses and protects any information that you give when using this website.

Information we gather

We may gather the following information:

- First and last name.
- Contact information including email.
- Statistical information on site traffic patterns.

How we use gathered information

We collect information to understand your needs and provide you with better service, in particular for the following reasons:

Cookie files
